February Board Meeting Highlights

Board Member Appointed

At its February meeting, the Board appointed Nola Castle as a Director to fill the vacancy created by the resignation of Sandra Williams last October. Castle will serve the remaining 15 months of Williams' term. The Board appointed Daniel Nardinelli, Jillian Powell, and Lucy Steffens to the Nominating Committee. Board Member Nola Castle will serve as Board Liaison to the Committee due to her previous experience on the Committee. *Note: Nardinelli subsequently was unable to serve, leaving a vacancy on the Nominating Committee. Any homeowner interested in serving should contact the Office.* The Committee manages the logistics of Candidate Night, scheduled this year for May 2 when residents seeking election to the Board discuss issues and answer questions posed by the Committee and homeowners. The Committee conducts a public drawing to determine the order candidates will be listed on the ballot.

Community Manager Report

Community Manager, Tamara Camara reported the Association passed its annual Fire Department inspection. She also, reported several roof leaks, water intrusion, and tree damage as a result of the winter storms. The Maintenance staff received 150 work orders in the previous month, completing 90 of them.

There are many other restoration and repair projects ongoing, the result of contracts approved by the Board. Three contracts were approved with Sac Val for plumbing and drainage projects, including \$2,050 to replace a valve near gate six, \$4,475 to replace a sewer line under unit 882, and \$19,984 to install two new storm drains near buildings 892 and 898. The Board also awarded a \$128,632 contract to Precision Concrete to repair uneven panels in sidewalks. Lastly, the Board awarded Adams Pool Specialties \$37,900 to re-plaster and tile spas in Old and East.

The Board is evaluating bids to repair satellite pool number 4, exterior elevated balcony and walkway repairs to comply with SB 326, and asphalt repairs at entrances to gates 1,2,3 and 5 and other locations.

Treasurer's Report

Treasurer Bill Sessa reported balances of \$173,230 in the Operating Account, \$1,118,959 in the Reserve Account, \$159,750 in the Flood Account, \$326,785 in Accounts Payable and \$58,860 outstanding in collections.

We will be performing work to enhance the safety and reliability of our natural gas system and may need access to your property. Please read for more information.

Dear Valued Customer:

The safety of our customers and the communities we serve is our most important responsibility. As part of that responsibility, we will be modernizing our natural gas pipelines in your community. This work may involve upgrading your gas meter(s) and will help enhance natural gas safety and reliability for you and your neighbors.

Our work will take place off near Woodside Sierra in Sacramento. We expect work to start on March 4th and continue through May. Weather and other factors that affect safe working conditions may change our schedule.

What you can expect

- We expect most work to take place Monday through Friday during normal business hours.
- You may see Pacific Gas and Electric Company (PG&E)/contractor crews, vehicles, and equipment as
 well as temporary markings on the ground to identify the location of underground utilities in the area.
- We may need access to your property to complete our work (and we will notify you if digging is required on your property to upgrade your gas service line).
- All personnel are required to carry valid photo identification and are happy to provide it upon request.
- We will do our best to minimize impacts, but you may hear intermittent construction noise.
- Our work should not interrupt your gas service. We will contact you if there are any changes and will
 provide details in advance.

Safe release of natural gas

There will be controlled and safe release of a small amount of natural gas. You may hear a loud and steady noise and notice the smell of gas. This is normal while crews are working, but we encourage anyone with concerns to call us at **1-800-743-5000**.

Potential traffic impacts

We will post "No Parking" signs at least 24 hours before we begin our work. Crews will route traffic around work areas if needed. Driveway access may be affected, but we can provide access upon request. Please plan for minor delays if we are working outside your home or business.
